The applicant is required to apply on plain paper giving their brief bio-data and self-attested copies of mark sheets/certificates/Degrees of academic qualification, research, and experience along with the original documents on the date of walk-in-interview. Commerce and Financial Studies	Commerce 04	<b>As per UGC norms</b> <b>i.</b> Good academics record with at least 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) at the Master's Degree level in a relevant subject from an Indian University, or an equivalent degree from an accredited foreign university. <b>ii.</b> Besides fulfilling the above qualification, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC CSIR, or similar test accredited by the UGC like SLET/SET. <b>iii.</b> Notwithstanding anything contained above in (i) and (ii), candidates, who are, or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2009 or <b>as amended from time to time</b> shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Guest Faculty. <b>iv.</b> Provided the candidates registered for the Ph. D programme prior to 11 July 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institutions awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions: a) The Ph.D. degree of the candidate has been awarded in regular mode only; b) The Ph.D. thesis has been awarded by at least two external examiners; c) An open Ph.D. viva voce of the candidate has been conducted; d) The candidate has published two research papers from his/her Ph.D. work out of which at least one is in a refereed journal; e) The candidate has presented at least two papers, based on his/her Ph.D. work in conferences/seminars sponsored/funded/supported by the UGC/ ICSSR/CSIR or any similar agency. The fulfillment of these conditions is to be certified by the registrar or the dean (Academic affairs) of the university concerned.

Com. with First Class or equivalent and two years of professional experience after acquiring the degree of Master's degree.
